New Councillors – Four new Councillors attended their first meeting and were welcomed by the Chairman. The new Councillors are Ruth Dale, Nigel Davis, Bob Ottway and Tracey Scott.

**Parish Council Meetings** – It was hoped that the next Parish Council meeting in September 2021, could be held in person at the village hall.

**Milcombe Newsletter** – Thanks were passed to Mark Boardman for continuing to print the MNL on behalf of the village.

Footpaths in Bloxham - Walkers going over Hobb Hill will notice posts and string at the gates and on the footpath. The farmer is using these to guide users to the location of the Public Right of Way. The farmer will be making hay in the field this year. If the ground becomes compacted it becomes unusable. Walkers should try to keep to the right, close to the hedge on the way up from Courtington Lane and at the top, walk straight down to the kissing gate at the bottom on Ells Lane. Please keep to the paths and enjoy your walks up Hobb Hill...a good pair of wellies / boots always helps.

Play Equipment – The contract for installing new play equipment in the village play area was awarded to Kompan and it was hoped installation would be undertaken later in the year, to avoid clashes with the school summer holidays. A quote would be obtained for cutting back the trees and bushes overhanging the boundary into the play area.

**Church Clock** – The Parish Council would be covering the cost of maintenance works to the Clock as its contribution to the village to mark HM The Queen's Platinum Jubilee in 2022.

Wheelie Bins – Residents are kindly requested not to block the footpaths with their wheelie bins, where possible. If they could also be collected back in as soon as they had been emptied, this would avoid the footpaths being blocked for those pedestrians with pushchairs or wheelchair users.

**Snow Warden/Grit Bins** – If anyone in the village would to volunteer to be a Snow Warden to help clear the footpaths in adverse weather conditions, please contact the Clerk to the Parish Council. Grit bins are all full and grit may be used on slippery public footpaths and roads only. It should not be used for private property use.

Register of Community Assets – Investigations would be made into registering community assets in the village, such as the Horse and Groom PH, Dovecote, village pump and the village shop.

**Highways** – Repairs which were required to potholes should be reported to the County Council's Fix My Street web site. https://fixmystreet.oxfordshire.gov.uk/ New road markings had been painted on the road by the junction at the Horse and Groom.

**Trees/Bushes/Hedges** - Residents were reminded that trees/bushes/hedges should not be causing an obstruction because they were overhanging a boundary onto a footpath or road. If an obstruction was occurring in the village, it should be reported to https://fixmystreet.oxfordshire.gov.uk/

#### PLEASE BE AWARE THAT THE FIELDS ADJACENT TO THE CHURCH ARE NOT PART OF A CIRCULAR WALK

When dog walkers disobey requests from land owners or farmers, (tenant or not) we lose the pleasure of walking our dogs in the open. There was a well used circular walk around Bloxham that had to be closed due to the need to "kill" livestock following contamination of cattle food from dog excrement. The dog excrement contained pathogens that caused cows to miscarry.

Fields around Milcombe with your dogs excrement left on the grass are harvested to become part of the winter food given to local cattle and livestock. Faeces can cause cysts in livestock grazing these fields. If the carcasses that contain cysts are missed by the meat health inspectors in the abattoir, this contaminated meat will end up in the food chain and be a danger to human health.

The responsible dog owner will always pick up after their dog and place into a dog bin, however wandering over the fields rather than keeping to the designated path/route enables dogs to run free and defecate where and when they like often not noticed by the owner or a blind eye is turned, this has now got to stop around Milcombe. The alternative could be to fence off and make it a much restricted walk for dogs and public alike.



## **MILCOMBE PLAY AREA**

As residents are aware, the Parish Council is planning to spend over £67,000 on new play equipment for the village.

This will involve removing the current equipment and replacing it with brand new, modern equipment. The Play Area Project Team, which includes two residents, has been working on this project for sometime and grant funding has recently been released which will enable it to progress.

There has been a lot of vandalism at the play area recently, which is causing the Parish Council some concern, given the investment we are planning to make in new play equipment. Significant damage has been caused to the multi play unit so it has had to be removed for safety reasons.

The Parish Council and the Project Team would like nothing more than see this project come to fruition, but to ensure this happens, we need support from the community. If you see anti-social behaviour happening, please ring 101 and report it to the Police and if you have older children, please remind them to look after and respect their environment which we all share. The Parish Council would not encourage residents to approach those involved and causing this damage, please leave that to the Police.

There have been suggestions about installing CCTV, which long term could be a solution, but initially we need quick, effective and practical solutions to ensure that the project can go ahead as planned and is not delayed.

The Parish Council hopes that residents understand these concerns and will support the project to improve the play area.

The Play Area is overseen by the Parish Council and contact is via the Clerk, Theresa Goss, milcombepc@gmail. com

There is a separate item regarding the vandalism which recently took place in the Play Area resulting in the multi- use wooden item having to be demolished as it was unsafe. The RoSPA annual safety inspection was carried out on the equipment in July which is a legal requirement and was still necessary despite the hopes for new equipment in the near future.

At their July meeting, Parish Councillors (in conjunction with the two residents who have been working on the Play project) agreed to accept the quotation from Kompan Ltd. of Milton Keynes at a total cost of just under £84,000 including VAT which the PC is able to re-claim. With most of the funding in place, it is hoped that the work will

be carried out later in the year when the Play Area will obviously need to be closed.

We trust that with a Play Area of brand new equipment, it will be respected.

THE PLAY AREA IS OPEN AND ALLOWING CHILDREN INTO THE PLAY AREA AND ON THE EQUIPMENT IS ENTIRELY THE RESPONSIBILITY OF PARENTS/GUARDIANS.

Despite some easing of restrictions, previous rules still apply. Parents/Guardians are encouraged to bring hand sanitiser or wipes to clean their children's hands. Children need to be reminded NOT to touch their faces, to cough or sneeze into a tissue or arm if tissue not available, and NOT to put their mouths on the equipment or their hands in their mouths. Food or drink are NOT allowed in the Play Area at the present time.

**PARISH GIVING SCHEME** – As everybody will appreciate, there has been very little income from Service collections over the past 18 months or so due to Covid and lockdown. However, in order to keep our Church open, it is imperative that we pay our insurance (over £1500 pa) otherwise the Church would remain locked and also to pay as much of our Parish Share as we are able (over £5000). At the same time, the PCC has to continue with the upkeep both of the Church building and the Churchyard. At the present time there is a section of the Churchyard boundary stone wall to the east of the Tower which has collapsed and in need of repair, we are awaiting a full electrical inspection which is a legal requirement, and the lightning conductor is in need of updating. Therefore, the PCC is asking if you will consider joining the Parish Giving Scheme which is a monthly amount of whatever you can afford paid by Direct Debit from your Bank and gift aid can be claimed where applicable. 





The Village Blacksmith. -Justin Tustain, blacksmith, of Milcombe, was charged with being drunk on the highway on December 26th. - Defendant pleaded not guilty, and said he had not been drunk for seven years. - P.C. Smith stated that on Saturday, December 26th, at about 7,30pm., from information he received from two gentlemen, he went in the direction of Milcombe, and found defendant lying by the side of the road in a gutter of water. Defendant asked him if he was going to let him stay there all night, and he replied that he was come to take him home. Defendant said he was

to go on about his business, and let him alone. He assisted defendant upon his fee, and he fell down again three or four times. A man named Tyrrell then came from the direction of Bloxham, and assisted to get defendant up. They assisted defendant some distance on the road, but defendant used very bad language, and said he would not be led home by any - policeman. Tyrrell promised to take him home, and witness, then left him. He was helplessly drunk. - Defendant said it was a poor, paltry case, and ought never to have been brought into Court; he was returning to Milcombe from his brother's house at Bloxham, and after walking about a mile along the road, his sight not being as good as it used to be, he stumbled into one of the dykes by the roadside, and could not get out of it. He sat in the

dyke for some time, when up came Mr. Policeman, and throws his light into defendant's face. He told the policeman to let him alone, as he had not said anything to anybody. The policeman tried to get him up, but could not manage it, so he sat there until up comes a Milcombe man, and he (defendant) went home with him. He was not drunk, and did not keep anything stronger then "tay" in his house. - Defendant was fined 2s 6d. and 10s. 6d. costs, which he paid rather reluctantly, protesting that "it was not justice, and didn't ought to be."
